The parties may renew the Agreement at the end of the duration as may be mutually agreed upon. Either party may terminate this Agreement without assigning any reason with one month's prior written notice to the other party.

3. PROJECT EXPENDITURE

The Company shall be responsible to incur and pay for all the direct and indirect expenditure in connection with the research project undertaken by it including that of the cost of equipments, consumables, travel, etc. to meet the overhead costs incurred in production of the instruments and/or the costs otherwise related to this work. However, the College undertakes to assist the Company in procurement and / or development of any equipment which may be necessary for the project and such procurement and / or development shall be out of the funds of the Company only. The equipment procured and / developed by the College out of the funds of the Company shall always belong to the Company.

Any Dispute which cannot be resolved through such conciliation within fifteen (15) days or such extended period as the Transferee and the Transferor may agree, shall be finally settled in accordance with provisions of the Arbitration and Conciliation Act, 1996 and any statutory modification or re-enactment thereof.
- 6.2. Such arbitration proceedings shall be conducted in Vijayawada, or in such other city as the Parties may mutually agree upon. The arbitration proceedings shall be conducted in the English language.
- 6.3. The arbitrators shall have powers to award and/or enforce specific performance.


