1. TECHNICAL ASSISTANCE & SUPPORT



2. DURATION

The parties may renew the Agreement at the end of the duration as may be mutually agreed upon. Either party may terminate this Agreement without assigning any reason with one month's prior written notice to the other party.

3. PROJECT EXPENDITURE

The Company shall be responsible to incur and pay for all the direct and indirect expenditure in connection with the research project undertaken by it including that of the cost of equipments, consumables, travel, etc. to meet the overhead costs incurred in production of the instruments and/or the costs otherwise related to this work. However, the College undertakes to assist the Company in procurement and / or development of any equipment which may be necessary for the project and such procurement and / or development shall be out of the funds of the Company only. The equipment procured and / developed by the College out of the funds of the Company shall always belong to the Company.

6. DISPUTE RESOLUTION


6.1. Any Dispute which cannot be resolved through such conciliation within fifteen (15) days or such extended period as the Transferee and the Transferor may agree, shall be finally settled in accordance with provisions of the Arbitration and Conciliation Act, 1996 and any statutory modification or re-enactment thereof.

6.2. Such arbitration proceedings shall be conducted in Vijayawada, or in such other city as the Parties may mutually agree upon. The arbitration proceedings shall be conducted in the English language.

6.3. The arbitrators shall have powers to award and/or enforce specific performance.

7. MISCELLANEOUS

7.1. This Agreement is not assignable by the College. The parties hereto agree that irreparable damage would occur in the event that any provision of this Agreement is not performed in accordance with the terms hereof and that the parties shall be entitled to seek and enforce specific performance of this Agreement, in addition to any other legal rights and remedies, without the necessity of demonstrating the inadequacy of monetary damages.
- 7.8. This Agreement is entered into in a spirit of goodwill and the parties covenant with each other that each party will render at all times all reasonable assistance in its power to facilitate successful implementation of this Agreement and/or provide any information or document in its possession, which the other Party may reasonably require for the purpose of this Agreement.


