EXAMPLES OF BEHAVIOUR THAT CONSTITUTE SEXUAL HARASSMENT

- 1. MAKING SEXUALLY SUGGESTIVE REMARKS OR INNUENDOS.
- 2.SERIOUS OR REPEATED OFFENSIVE REMARKS, SUCH AS TEASING RELATED TO A PERSON'S BODY OR APPEARANCE.
- 3. OFFENSIVE COMMENTS OR JOKES.
- 4. INAPPROPIATE QUESTIONS, SUGGESTIONS OR REMARKS ABOUT A PERSON'S SEX LIFE.
- 5. DISPLAYING SEXIST OR OTHER OFFENSIVE PICTURES, POSTERS, MMS, SMS, WHATSAPP, OR E-MAIL
- 6. INTIMIDATION, THREATS, BLACKMAIL AROUND SEXUAL FAVOUR.
- 7. THREATS, INTIMIDATION OR RETALIATION AGAINST AN EMPLOYEE WHO SPEAK UP ABOUT UNWELCOME BEHAVIOUR WITH SEXUAL OVERTONES.
- 8. UNWELCOME SOCIAL INVITATIONS, WITH SEXUAL OVERTONES COMMONLY UNDERSTOOD AS FLIRTING.
- 9. UNWELCOME SEXUAL ADVANCES WHICH MAY OR MAYNOT BE ACCOMPANIED BY PROMISES OR THREATS, EXPLICIT OR IMPLICIT.
- 10. Physical contact such as touching or pinching.
- 11. Caressing, Kissing or fonding someone against her will (could be considered as assault).
- 12.Invasion of Personal Space(Getting too close for no reason, Brushing against or cornering someone).
- 13. PERSISTENTLY ASKING SOMEONE OUT, DESPITE BEING TURNED DOWN.
- 14. STALKING AN INDIVIDUAL.
- 15. ABUSE OF AUTHORITY OR POWER TO THREATEN A PERSON'S JOB OR UNDERMINE HER PERFORMANCE AGAINST SEXUAL FAVOUR.
- 16. Falsely accusing and undermining a person behind closed doors for sexual favour's.
- 17. CONTROLLING A PERSON'S REPUTATION BY RUMOUR-MONERING ABOUT HER PRIVATE LIFE.



The event facilitated networking among students, faculty, and guest speakers, creating a supportive community where women and girl students could connect, share experiences, and mentor each other.






