## ORDER:

In the G.O. (1) read above, the newly sanctioned Private Engineering Colleges and Pharmacy Colleges were directed to obtain affiliation from JNT University. The University has constituted an Expert Committee to examine the existing facilities and plans of the Rajeev Gandhi Memorial College of Shove

ir pursuance of the resolution under Item 4.01 of the 2nd pased on the Executive Council meeting held on 5.7.1995 and pleased to grant provisional and temporary affiliation to the Raisey Candhi Memorial College of Engineering & Technology Rajeev Gandhi Memorial College of Engineering & Technology spensored by Parameswara Educational Academy for offering following disciplines and intake for the academic year 1995-96:-

The affiliation shall be subject to the following conditions and also general rules of affiliation of the University:

- The admissions should be made only from the candidates allotted by the Convener, EAMCET 1995.
- The Institution shall appoint the required number of teachers on a full-time basis following the qualifications prescribed by the AICTE/University and procedures laid down by the Government/JNT University.

- 3. They shall provide necessary facilities like Library, Laboratories etc., as recommended by the Inspection Committee/University.
- 4. They shall admit students according to eligibility and procedure laid down by the University.
- They shall collect fee as per the fee structure prescribed by the Government/University.
- 6. The College Management shall spend the amount as prescribed by the University each year for purchase of Library books.
- 7. The College Management shall form a separate governing body exclusively for the Engineering College consisting of the specified number of members as prescribed by the University rules of affiliation.
- 8. The College Management shall construct buildings exclusively for the College from their own funds.
- 9. The College Management shall not divert any amounts to the Engineering College from any of the existing other Educational Institutions under their control and viceversa.
- 10. The College Management shall pay the salaries to the staff as prescribed by the Government/UGC/JNT University.
- 11. The College Management shall run and manage the college without any financial aid or assistance from the Government or University either now or in future.
- 12. The Management shall not collect any donation/capitation fee from the students for any purpose.
- 13. The Management shall not change premises of the College without prior approval of the University.
- 14. The Management shall contribute the amount towards conduct of examinations as will be communicated by the University.
- 15. The management should immediately take action to fulfil! the land requirements as per the AICTE norms.
- 16. i) The sheds for the Physics & Chemistry Labs and workshops with floor area of about 600 Sqm should be erected as per the Expert Committee Report.

- Procurement of equipment and installation of the ii) Labs and workshops by the end of August 1995.
- Recruitment of teaching and non-teaching staff iii) should be completed by the end of August 1995.
- The Management shall meet the requirements of infrastrictural facilities, establishment Laboratories and Workshops and faculty recruitment as of detailed in the Expert Committee report, latest by first week of September, 1995.
- The Management shall follow the norms of AICTE and the rules of affiliation of JNT University in all aspects.
- The Management shall follow the academic regulations, and examination schedule of JNT University.
