The college, if eligible, shall apply for autonomy grants per the norms laid down in the Regulations.

The autonomous college is required to abide by all the provisions of the UGC Regulations for Autonomous Colleges. The Regulations are available on the UGC website, www.ugc.ac.in. However, the college may take special note of the following:

- (a) In case a college does not fulfil the eligibility conditions related to accreditation as laid down in the Regulations, such college shall be required to comply with the eligibility conditions within a maximum period of five years from the date of notification of these Regulations.
- (b) The college shall also apply in the prescribed format to University Grants Commission for extension of autonomous status six months prior to the expiry of the autonomous cycle.
